Butler County-- Ahead of the West

Despite population flat lines and losses across much of western Pennsylvania, Butler County has experienced population growth-- 14.1 percent, to be exact.

Dave Johnston of the Butler County Planning Commission will discus reasons why Butler County has thrived during the past ten years. His explanations will include an analysis of Butler County's tax collection, transportation and road access, public utility availability and land characteristics.

Dave Johnston has been serving as Planning Director for Butler County for six years. He has over 23 of years experience in county government serving both rural and urban environments. He is a member of the Southwestern Pennsylvania Commission and a volunteer on the Butler YMCA Board of Directors as well as the Cranberry Township Building and Fire Code Appeals Board, Butler Area Chamber of Commerce Board of Directors and Butler County Mental Health/Mental Retardation Steering Committee.

Pennsylvania Tobacco Settlement Money

Pennsylvania will receive \$11 billion over the next quarter century from the tobacco settlement of 1998. Governor Ridge's "Health Investment Plan" provides that all monies from the settlement will be used for health care purposes.

Ms. Kissinger will discuss the overall impact of the tobacco settlement on Pennsylvania hospitals and health systems with specific emphasis on the uncompensated care/extraordinary expense program and the Health Link program. The discussion will touch on how the state's hospitals are affected by other provisions of the new tobacco settlement law and how they will be community partners in several of the health initiatives created under Act 77 of 2001.

Dr. Monismith will discuss how funds have been and will be allocated for comprehensive tobacco control as well as prevention and cessation programs across the commonwealth.

Ms. Kissinger joined The Hospital and Healthsystem Association of Pennsylvania in March 1994 as Director of Political Development. Prior to her current position, Ms. Kissinger was director of the Senate Republican Communications office.

Dr. Monismith is an Associate Professor of Health Education at Penn State Harrisburg. He serves as Academic Coordinator for Graduate Studies in Health Education.

Deregulation in Pennsylvania

Glen Thomas, Chairman of the Pennsylvania Public Utility Commission, will discuss the current status of deregulation in Pennsylvania as it pertains to the telecommunications, gas and electric industries. One focus will be electric reliability and how Pennsylvania compares to California. He will also provide an overview of the Verizon local competition case in Pennsylvania.

Governor Tom Ridge named Thomas as Chairman of the Pennsylvania Public Utility Commission on June 22, 2001. Prior to his appointment to the commission, he was deputy director of Governor Ridge's Policy Office, having served in the Policy Office since 1995. During his tenure in the Ridge Administration, Chairman Thomas also served as the governor's principal advisor on several hallmark initiatives, including electric and natural gas competition. He was also Governor Ridge's top aide during the governor's term as Chairman of the Council of Great Lakes Governors. Chairman Thomas currently serves as a member of the National Association of Regulatory Utility Commissioners, the Mid-Atlantic Association of Regulatory Utility Commissioners, and the State Government Liaison Committee of the Pennsylvania-New Jersey-Maryland Interconnection.
