Pennsylvania Continues to Show Slight Population Increase

MIDDLETOWN, Pa – The U.S. Census Bureau today released the 2003 National and State Population Estimates and Estimated Components of Change. The July 1, 2003 Estimates are developed by carrying forward births, deaths and migration data from April 1, 2000 (estimate base). An estimated 12,365,455 persons resided in Pennsylvania in 2003. This is a 0.7 percent increase from the 2000 estimate base of 12,281,054 persons, a 0.5 percent increase from the 2001 estimate of 12,298,363 persons and a 0.3 percent increase from the 2002 estimate of 12,328,827 persons.

Nationwide

The total population in the United States was 290,809,777 persons in 2003, an increase of 3.3 percent from the 2000 estimate base of 281,423,231 persons. California remained the most populous state with an estimated 35,484,453 persons in 2003. Texas remained the second largest state with an estimated population of 22,118,509 persons. Pennsylvania continued to rank sixth in the nation in terms of 2003 overall estimated population.

Elderly Population

Pennsylvania continues to rank second to Florida in terms of having the highest percentage of the population age 65 and over (Table 1). According to the 2003 population estimate, 15.4 percent of the total population in Pennsylvania is age 65 and over, a decrease of 0.2 percent from 2000. Alaska had the lowest percent elderly population in 2003, with only 6.3 percent of its total population being age 65 and over.

Internal Migration

The number of people moving into Pennsylvania from other states has been increasing since 2001. In 2001, there was a net internal migration loss of 19,017 persons. In 2003, there was a reported net migration gain of 7,841 persons. Pennsylvania continues to gain population from international migration. From April 1, 2000 to July 1, 2003 Pennsylvania shows a net increase of 68,935 persons from international migration.



Estimated Population Percent Change April 1, 2000 Estimate Base to July 1, 2003




