## Low to Moderate Household Income Summary Data Available from HUD

MIDDLETOWN, Pa – The Pennsylvania State Data Center at Penn State Harrisburg reports that low to moderate household income summary data estimates have been made available by the U.S. Department of Housing and Urban Development (HUD). This summary data is available for the block group geographic level designated by the U.S. Census Bureau. Each block group is identified by its Federal Information Processing Standards (FIPS) code in addition to the HUD Unit-of-Government-Identification-Code for the Community Development Block Grant (CDBG) grantee with jurisdiction over the block group area. These estimates can be used to develop grant proposals, focus on areas that need special attention and provide supplementary demographic information.

Each block group is listed according to the latest block group records by local government and by CDBG grantee jurisdiction. The fiscal year 2004 edition, which is the most recent release, contains information that was updated between the 2000 Census (April 1, 2000) and December 2002. The previous edition for fiscal year 2003 was based on records available at the time of the 2000 Census. Another change is the realignment of the block group records by CDBG jurisdiction to reflect the fiscal year 2004 configuration of metropolitan cities and urban counties.

The statistical information used in the calculation of the estimates is extracted from three tables in the Census 2000 Summary File 3 (SF3) dataset. This dataset is compiled from responses to the 2000 Census long form questionnaire and collected from a sample of the population. The three SF3 tables used for the estimates are: Household Type (Including Living Alone) by Relationship; Family Income in 1999; and Non-family Household Income in 1999. These tables are used with Income Limits for Metropolitan Areas and for Non Metropolitan Counties prepared by the HUD's Office of Policy Development and Research to calculate the low to moderate income limits for 1999 (Table 1).

These income limits are combined with the data tables from Census 2000 to calculate three income levels: Moderate Income (80 percent) level, Low Income (50 percent), and Very Low Income (30 percent) level. Estimates are also calculated for (1) the number of family households below each income level; (2) the number of non-family households below each income level; (3) persons in family households below each income level; (4) persons in non-family households below each income level; (5) total households below each income level; and (6) total persons in households below each income level.
