

## Pennsylvania Receives \$94.9 Billion in Federal Funds, 5<sup>th</sup> Highest in Nation

MIDDLETOWN, Pa –Pennsylvania received \$94.9 billion dollars in federal funding in 2004 according to the recently released *Consolidated Federal Funds Report for Fiscal Year 2004*. The commonwealth's share of funding represents 4.4 percent of the \$2.2 trillion spent by the federal government and ranks 5<sup>th</sup> among the states.

Published annually by the U.S. Census Bureau, the *Consolidated Federal Funds Report* details expenditures on benefits, subsidies, grants, goods and services, salaries and wages, and contains federal agency and program-level data on grants to state and local governments. This report provides data at the state, county, and local levels for federal domestic spending. The report does not cover interest on national debt because there is no meaningful way to assign payments on the national debt to a particular geography. The report also does not cover intelligence spending because the CIA and other intelligence agencies do not report the geographic disbursement of expenditures.

Of the \$94.9 billion distributed to Pennsylvania in 2004, \$33.1 billion, or 34.9 percent of the total, went to retirement and disability programs, \$25.9 billion (27.3 percent) was allotted to other direct payments, almost \$20 billion went toward grants, \$9.3 billion was spent on procurement, and \$6.6 billion was paid out in salaries and wages.



An analysis of retirement and disability program expenditures shows that of the \$33 billion spent in Pennsylvania, nearly \$17 billion went toward retirement insurance payments, \$5.4 billion went toward survivors insurance payments, \$37.7 billion was allotted for disability insurance payments, and \$1.6 billion was spent on supplemental security income payments. Additionally, a little over \$1 billion was spent on benefits for veterans and their families.

## Other data shows:

- Of the \$25.9 billion expended on other direct payments, \$18.4 billion was spent on Medicare benefits, an increase of approximately \$1.6 billion over 2003, while unemployment compensation decreased by \$900 million dollars to \$2.6 billion in 2004.
- Medical assistance programs (\$8.4 billion) and highway planning and construction (\$1.5 billion) were among the top federal grant recipients.
- Defense expenditures accounted for about \$9 billion dollars in federal funding in 2004.

On a per capita basis, Pennsylvania received \$7,649.36 per person from the federal government in 2004, 19<sup>th</sup> among the states. Table 1 shows the per capita breakdown of expenditures by program category. Please note that the July 1, 2004 estimated population of 12,406,292 was used for these calculations.

The \$94.9 billion in federal funds that Pennsylvania received in 2004 represents a 5.0 percent increase over 2003. Since 1994, the amount of federal funding directed to the commonwealth has increased by 58.0 percent. Nationally, federal spending increased by 4.9 percent from 2003, and has grown by 31.0 percent since 2000.

Allocation of funding to Pennsylvania counties can also be found in the *Consolidated Federal Funds Report for Fiscal Year 2004*. Philadelphia again led all counties in 2004, receiving \$16.1 billion in federal funds, followed by Allegheny (\$11.9 billion) and Dauphin (\$5.0 billion) counties. Together, Allegheny and Philadelphia counties accounted for 29.4 percent of the federal funds spent in Pennsylvania. Dauphin County received the most funding on a per capita basis (\$19,615.72 per resident), followed by Philadelphia (\$10,920.86) and Allegheny (\$9,473.82) counties. Pike (\$3,437.01), Chester (\$4,138.18), and Lancaster (\$4,227.83) counties received the fewest federal funds per resident. (Table 2)
