

## Per Capita Income in Pennsylvania Reaches \$33,000

MIDDLETOWN, Pa –Per capita personal income in Pennsylvania reached \$33,257 in 2004 and ranked 18<sup>th</sup> nationally, according to the January issue of the *Survey of Business*, recently released by the U.S. Bureau of Economic Analysis (BEA). Per capita personal income in the commonwealth increased \$1,527 between 2003 and 2004, and has increased by more than \$5,000 since 1999.

Personal income in Pennsylvania totaled \$435.4 billion in the 3<sup>rd</sup> quarter of 2005, 1.0 percent higher than the previous quarter (\$431.2 billion) and 5.2 percent higher than the 3<sup>rd</sup> quarter of 2004 (\$414 billion). However, the average annual growth rate of personal income in Pennsylvania between 1994 and 2004 is better than just 5 other states.



#### **Disposable Income and Earnings**

Defined as total after-tax income received by persons, per capita disposable personal income in Pennsylvania reached \$29,656 in 2004 and ranked 18<sup>th</sup> nationally. Per capita disposable income increased \$1,371 over 2003, and by \$5,555 since 1999. Disposable income in the commonwealth totaled \$367.9 billion in 2004.

Earnings in the 3<sup>rd</sup> quarter of 2005 totaled \$328 billion, an increase of 1.3 percent over the previous quarter. Wages and salaries accounted for 71.7 percent (\$235.3 billion) of earnings, while employer contributions toward pensions and insurance made up 17.2 percent (\$56.4 billion) of the total.

Private industry earnings (\$284.3 billion) made up 86.9 percent of total nonfarm earnings in the 3<sup>rd</sup> quarter of 2005, while government earnings (\$43 billion) accounted for 13.1 percent –three-quarters of which was state and local. The top 3 earnings totals by private industry in the 3<sup>rd</sup> quarter were: manufacturing (\$48 billion), health care and social assistance (\$41.4 billion), and professional and technical services (\$30.4 billion). The health care and social assistance industry (+0.24 percent) lead all Pennsylvania businesses in terms of contributions to percent change in earnings between the 2<sup>nd</sup> and 3<sup>rd</sup> quarters of 2005, followed by real estate (+0.15 percent), and wholesale trade (+0.9 percent).

## Personal Income in Pennsylvania Metropolitan Areas and Counties


The New York-Northern New Jersey-Long Island, NY-NJ-PA (\$40,899) and Philadelphia-Camden-Wilmington, PA-NJ-DE-MD (\$37,059) metropolitan statistical areas (MSA) led all Pennsylvania MSAs in per capita personal income in 2003. These two areas also ranked 9<sup>th</sup> and 21<sup>st</sup> nationally in per capita income. The Philadelphia-Camden-Wilmington, PA-NJ-DE-MD (+\$1,150) and Lancaster (+\$1,004) MSAs experienced the highest per capita income growth between 2002 and 2003. Five of the 16 MSAs located in Pennsylvania were ranked among the top 100 nationally in per capita income. (Table 1)

Montgomery (\$49,429), Chester (\$47,480), and Bucks (\$40,450) led all Pennsylvania counties with the highest per capita personal income in 2003, while Greene (\$21,539), Tioga (\$21,277), and Huntingdon (\$20,539) counties had lowest per capita income. Montour County showed the highest increase in per capita income (+\$1,317) between 2002 and 2003, while Potter was the only county to experience a decline (-\$102). (Table 2)

#### **Gross State Product**

The commonwealth's gross state product in 2004 was \$468 billion, 6<sup>th</sup> among the states, and per capita

gross state product rose to \$37,730. Financial activities accounted for the largest share of Pennsylvania's gross state product (19 percent) at \$91.7 billion. Manufacturing, long considered an important if declining part of Pennsylvania's economy, generated \$75.3 billion, or about 16 percent of the gross state product. commonwealth also ranked 4<sup>th</sup> nationally in economic output from non-durable goods manufacturing (\$40.9



billion) in 2004. Trade (\$58.4 billion) and professional and business services (\$51.5 billion) were significant components of Pennsylvania's gross state product, and the education and health services sector, which has become increasingly important to the state's economy in recent years, generated \$50.3 billion, the fourth highest output nationally from this industry. Government contributed \$44.9 billion toward the commonwealth's gross state product in 2004.

### **Regional Growth**

The BEA classifies Pennsylvania as a component state of the Mideast Region, which includes Delware, Maryland, New Jersey, New York, and Washington, D.C. Personal income and gross state product in Mideast states as shares of total U.S. income and gross domestic product have declined in recent decades. In 1969, personal income in the Mideast accounted for 23.5 percent of all personal income in the U.S, the most of any region. As of 2004, that figure had fallen to 18.5 percent, and was overtaken by the Southeast (22.5 percent). In 1977, gross state product in the Mideast comprised 20.3 percent of the U.S. gross domestic product, again the largest share of any region. In 2004, the Mideast's share had declined to 18.4 percent, and was surpassed by the Southeast (22.3 percent).


