2006 Detailed State Population Estimates Released: Hispanic and Minority Groups Account for All of Pennsylvania's Population Growth

MIDDLETOWN, Pa –The U.S. Census Bureau recently released July 1, 2006 estimates of the population based on sex, age, race and Hispanic origin. The release includes detailed population estimates for Pennsylvania at the state level. The data illustrates the commonwealth's changing demographics, showing that minorities and persons of Hispanic origin now account for all of the state's population growth. Overall, the populations of several age groups, including persons 25-44 and children under the age of 18 have declined. The state's total population has increased to 12,440,621, from 12,405,348 in 2005 (a 0.2 percent increase) and 12,281,054 in 2000 (a 1.3 percent increase).

Race and Hispanic Origin

The Hispanic population in Pennsylvania (526,976) continued to increase in 2006. The number of persons of Hispanic or Latino Origin increased 5.1 percent from 2005 to 2006, and grew by 33.7 percent over the last 6 years. In comparison, the non-Hispanic population increased just 0.1 percent last year and 0.2 percent since 2000. Hispanics account for 83.2 percent of all population growth in Pennsylvania between 2000 and 2006. However, Hispanics make up just 4.2 percent of the total population in the commonwealth. Hispanic or Latino origin is considered an ethnicity by the U.S. Census Bureau and persons of Hispanic origin may be of any race.

The White population is the only race group in Pennsylvania that is losing population, with the non-Hispanic White population decreasing by 0.2 percent between 2005 and 2006 (-16,827). Since 2000, the non-Hispanic White alone population has fallen by 130,160 persons (-1.3 percent). Between 2005 and 2006, non-Hispanic Black and Asian (Alone) populations grew by 11,529 and 11,066 persons, respectively. In the last six years, Pennsylvania's non-Hispanic Black (+67,756) and Asian (+65,555) populations increased by 5.6 percent and 29.4 percent, respectively. Also, non-Hispanic Asians, Native Hawaiians or Pacific Islanders, and persons of two or more races have grown by more than 69.5 percent since 2000. Despite population loss, the White alone race group still comprises 85.7 percent of the total population in the commonwealth. (Table 1)

Age and Sex

Several age groups have declined in population over the last six years. Pennsylvania's elderly population (65 years or older) has dropped by 33,842 persons (-1.8 percent) since 2000. The 25-44 age group experienced the largest population loss (-283,936 or -8.1 percent) while children (under 18) declined by 117,348, or -4.0 percent during this period.

Pennsylvania remains one of the oldest states in the nation, ranking 3rd in percentage of persons 65 and over (15.2 percent) in 2006. The median age of all Pennsylvanians has increased from 38.0 to 39.5 since 2000. As of July 1, 2006, the commonwealth's male (6,047,537) and female (6,393,084) populations stood at 48.6 percent and 51.4 percent of the total population, respectively. Among the elderly, the ratio shifts to 40.7 percent male, 59.3 percent female.
