

## Pennsylvania Receives \$103.3 Billion in Federal Funds, 5<sup>th</sup> Highest in Nation

MIDDLETOWN, Pa –Pennsylvania received \$103.3 billion dollars in federal funding in 2006 according to the recently released *Consolidated Federal Funds Report for Fiscal Year 2006*. The commonwealth's share of funding represents 4.2 percent of the \$2.5 trillion spent by the federal government and ranks 5<sup>th</sup> among the states.

Published annually by the U.S. Census Bureau, the *Consolidated Federal Funds Report* details expenditures on benefits, subsidies, grants, goods and services, salaries and wages, and contains federal agency and program-level data on grants to state and local governments. This report provides data at the state, county, and local levels for federal domestic spending. The report does not cover interest on national debt because there is no meaningful way to assign payments on the national debt to a particular geography. The report also does not cover intelligence spending because the CIA and other intelligence agencies do not report the geographic disbursement of expenditures.

Of the \$103.3 billion distributed to Pennsylvania in 2006, \$36.4 billion, or 35.3 percent of the total, went to retirement and disability programs, \$28.9 billion (28.0 percent) was allotted to other direct payments, \$20.2 billion went toward grants (19.6 percent), \$10.8 billion was spent on procurement (10.5 percent), and \$6.9 billion was paid out in salaries and wages (6.7 percent).



Other data shows:

- Social Security programs topped the list of Retirement and Disability expenditures, with Social Security Retirement insurance totaling \$18.4 billion, Social Security survivor's insurance totaling 5.8 billion, and Social Security disability insurance totaling \$4.6 billion.
- Of the \$28.9 billion expended on other direct payments, \$21.4 billion was spent on Medicare benefits, an increase of approximately \$800 million over 2005, while unemployment compensation decreased by \$86 million dollars to \$1.9 billion in 2006.
- Medical assistance programs (\$9.3 billion) and highway planning and construction (\$1.8 billion) were among the top federal grant recipients in Pennsylvania in 2006.
- Defense expenditures accounted for about \$10.4 billion dollars in federal funding in 2006.

On a per capita basis, Pennsylvania received \$8,300.61 per person from the federal government in 2006, 21<sup>st</sup> among the states. Table 1 shows the per capita breakdown of expenditures by program category. Please note that the July 1, 2006 estimated population of 12,440,621 was used for these calculations.

The \$103.3 billion in federal funds that Pennsylvania received in 2006 represents a 3.8 percent increase over 2005. Since 2000, the amount of federal funding directed to the commonwealth has increased by 40.0 percent. Nationally, federal spending increased by 7.5 percent from 2005, and has grown by 48.7 percent since 2000.

Allocation of funding to Pennsylvania counties can also be found in the *Consolidated Federal Funds Report for Fiscal Year 2006*. Philadelphia led all counties in 2006, receiving \$17.7 billion in federal funds, followed by Allegheny (\$14.9 billion) and Montgomery (\$5.5 billion) counties. Together, Allegheny and Philadelphia counties accounted for 31.6 percent of the federal funds spent in Pennsylvania. Dauphin County received the most funding on a per capita basis (\$18,083.50 per resident), followed by Luzerne (\$13,241.38) and Philadelphia (\$12,221.09) counties. Lancaster (\$5,520.02), Pike (\$5,533.32), and Berks (\$5,738.19) counties received the fewest federal funds per resident. (Table 2)
